#### Social justice action and advocacy resources (Draft Summary)

How can we take action on the issues that maintain systematic racism?

Description: Outreach proposes to identify some of the key issues related to system racism, educate ourselves on the issues and then look at opportunities for service around those issues, through volunteering and advocacy. We have organized it around Poverty and Economic Inequality, Education, Criminal Justice System, Voting rights and Environmental Justice.

Alternatively, we could organize this around the issues identified on the UMCJustice.org website - for General Board of Church and Society – outlines four major areas: Poverty, Climate, Health and Peace.

We would like to leverage the current relationships we have with organizations such as OAR, Bridges to Independence and AFAC.

# c. Criminal Justice System

What the UMC has to say: Criminal Justice Reform

"A justice system that reflects God's desires for the world is one that is healing and restorative." (Book of Resolutions, 5031)

The church supports "measures designed to remove social conditions that lead to crime, and we encourage continued positive interaction between law enforcement officials and members of the community at large." (Social Principles, ¶164.H)

The United Methodist Church calls on government and society to "stop criminalizing communities of color in the United States" by dismantling unjust, racist policies and practices, including racial profiling, mass incarceration and communal disenfranchisement. (<u>Book of Resolutions, 3379</u>)

"In the love of Christ, who came to save those who are lost and vulnerable, we urge the creation of a genuinely new system for the care and restoration of victims, offenders, criminal justice officials, and the community as a whole." (Social Principles, ¶164.H)

"Cohort participants will engage in formal learnings and conversations to analyze, confront, and address the racial patterns that are embedded in our lives and that are all too readily accepted as the norm. Topics will include the history of racism; the impact of vocabulary and language; racial superiority/inferiority; white fragility; white energy; the conditioning of People of Color; and the weathering that the latter experience as they face racism on a daily basis or raise their voices to challenge white supremacy. The cohorts will be a place where individuals will explore their beliefs and day to day behaviors. Cohort groups will likely meet virtually once or twice a week for 2-to-4-hour sessions over the three months of the program

First one September to November

Second in January to March of 2021

Will limit to 20-25 people

Application form – there is a cost of \$750 – larger groups can receive a discount \$500/person of 10 or more. There will be scholarships

Poverty – Faithful Finance, Global Hunger and Poverty, Hunger and Poverty in the U.S., Worker Justice

Climate – Clean Water, Climate Justice, Food Justice, Sustainability

Health – Addictions, Global Health, Health Care in the U.S., HIV and AIDS, Mental Health Peace – Multilateralism, Nonproliferation/Disarmament, Peacebuilding, Gun Violence Prevention, Ongoing Conflicts

Under Health – Health Care in the U.S. would likely be a platform for looking at health disparities among minority populations, impact of COVID, etc Under Peace – Gun Violence could lend itself to exploring the impact of this on minority communities
